The Canadian Centre for Occupational Health and Safety, located in Canada's most industrialized city, Hamilton, was set up as an access for workers, both union and non-union, companies, and others to the most up-to-date information about chemicals and other dangers present in the workplace. Believe it or not, Mr. Speaker, the Treasury Board has now told the Canadian Centre for Occupational Health and Safety

that it must raise \$1 million in private funds by 1992 if it is to

The time has come for the workers of the country to tell the Government that the lives and health of working people are not to be bartered away by the almighty dollar. It will be impossible for the Centre to raise the \$1 million by the end of 1992. That will spell the end of the Centre.

I think it is a crying shame for the people of the country that the Government does not believe in getting information out to workers about chemical spills and other labour hazards in the workplace. That is the role of the Government. It is not the role of a private company to pay for the Canadian Centre for Occupational Health and Safety. The Treasury Board had better get that message.

CANADA-UNITED STATES TRADE AGREEMENT—SCHEDULING OF COMMITTEE HEARINGS
