PROPOSED GOODS AND SERVICES TAX

Mr. Brian O'Kurley (Elk Island): Mr. Speaker, in the riding of Elk Island a hard working music producer in the Sherwood Park area has informed me that the current manufacturer's sales tax is crippling the western Canadian music industry.

This Albertan is well known for his contributions to Canadian music as a performer and as a producer. He said that under the current federal sales tax, the MST, Alberta record stores are required to pay the federal sales tax before their product is sold. He recommends a federal sales tax at the point of consumption rather than at the point of production. He says that the GST will help.

We must work together to diversify the economy of western Canada. Our government must take a leadership role in helping the music industry in western Canada. The Government of Canada must replace the existing federal sales tax, the MST, in order to build a stronger economy in western Canada.

MEECH LAKE ACCORD

MEECH LAKE ACCORD
