#### HIBERNIA DEVELOPMENT PROJECT ACT

#### MEASURE TO AMEND

The House resumed from September 26, consideration of Bill C-44, An Act respecting the Hibernia Development Project and to amend certain Acts in relation thereto, as reported (with amendments) from a legislative committee; and motions Nos. 1 and 2 of Mr. MacDougall (p. 13462) and the amendment of Mr. Plamondon (p. 13468).

Mr. Gabriel Fontaine (Lévis): Madam Speaker, on September 14 1990, the Government of Canada announced the conclusion of an agreement with a consortium of private companies concerning the Hibernia development Project.

Today, the House is asked to adopt a Bill that would allow lenders to lend money to that consortium for the duration of the capital project.
