Thursday Evening, Fcb. 4.

War talk was as freely discussed and as effective in retarding speculation on the local exchange to-day as at larger centres. There was an indisposition to make commitments, but the lower prices in the active issues allowed of some closing up of short accounts that gave the market a more active appearance. Coal was decidedly weak in the early trading, and sold down thru the former low price of last year to 59. At this level, some support came in, and the price ruled firmer during the balance of the day. C.P.R. was pressed during the afternoon and sales were freely made below 118 with the cosing sale at 117½. A local broker reports an investment demand for the stock from German bankers, and says that the stock is showing a decided scurceness on the Toronto market. Tractions were dull, but only fractionally lower than vesterday. A sympathetic weakness with Domoinion Coal brought N. S. Steel down to 77, but trading in the stock was light. Navigntions lacked firmness, and Northern made a new low level of 70, on a five-share lot. The rest of the list was comparatively steady.
