

Liberal-Labor Move Urged

Government with a Liberal wing.

It is recalled that the Laborites repudiated any idea of co-operating with the Liberals.

LONDON, Oct. 30.—What is apparently an official bid from the Liberal for co-operation between the Liberal and Labor parties was launched last evening at a Liberal meeting under the chairmanship of the Earl of Oxford and Asquith, the party leader.

The speaker was Prof. Gilbert Murray, who claimed close affinity between the Liberal and Labor parties and said the Socialistic tenets of the Laborites troubled him very little, because state action was bound to increase with the development of society.

If the expulsion of the Communists from the Labor party, so forcibly pronounced by Ramsay MacDonald at the recent Liverpool congress, was successful, the natural consequence, Prof. Murray believed, would be a gradual rapprochement between Labor and Liberalism.

He suggested, as the best plan, a Liberal Government with a Labor wing, and, as second best, a Labor Government with a Liberal wing. Lord Asquith cordially endorsed the proposal.
