## BITUMINOUS MACADAM

### IS TRIED IN BANGOR

#### First Roadway of Kind There—How It is Laid

(Bangor Commerce)

The street department of the city of Bangor is building a new strip of highway in Broadway of which great things are expected, this being the first of this kind of road that has ever been constructed here. It is being built on the south side of the main road from State to Penobscot streets, and is of bituminous macadam.

The process of building involves a dry waterproof road of unusual firmness and smoothness, which will outlast the other varieties of roads a number of years and requires much less attention. Properly constructed it is dustless.

The road is prepared with a coating of coarse crushed stone, which is rolled down with the steam roller. On this is applied what is known as a "binder," an asphalt preparation, which is one of the Standard Oil Co.'s by-products, and which is heated to a temperature of 400 degrees before applying. Over this is spread another coat of crushed rock for the road surface, and that is rolled in. The road, by this time is in shape for use, and owing to the action of the asphalt binder it becomes practically dustless. Miles and miles of this road have been built in the state of Massachusetts, and it is now in use in practically every state in the union. It can be constructed at the cost of about \$1 a square yard, and it is much better than the oil sprinkled roads.

The oil sprinklers, which have been at work in this city, have covered 40,000 square yards, or a square five miles long and 18 feet wide. The oil that is being used is 40 per cent. asphalt and serves as an excellent binder, the continual application of it, oil from year to year giving in time the effect of an asphalt road.
