The meeting was well attended, and the president, Mrs. McCullum, who was elected to office for another year, occupied the chair.

The meeting was opened with devotional exercises, led by Rev. George Bishop, and the report of Miss Florence Macdonald, who has been the most zealous in her work was received. It was a very satisfactory report, being a practical outline of the work done during the year. It said that the home had reason to feel grateful for the satisfactory manner in which the year's work had been carried on, and that the home had been blessed with the boys and girls of the home.

The boys and girls of the home had the best of health, only one serious illness, coming under the attention of the physicians, Drs. Niven and Stevenson, who had so kindly proffered their services. On Oct. 1, 1902, there were in the home 22 boys and 19 girls. Since that time 13 boys and 7 girls had been brought in, making a total of 35 boys and 26 girls, who in the past year had at any time been in the home.

In the course of the year, however, 14 boys and 15 girls had been given homes, so that at present there are 20 boys and 11 girls in the home. The foster homes secured for the children had been satisfactory, good reports of them being frequently received. Miss Auld, the matron and her assistants, have performed their duties efficiently and deserved much thanks. Improvements to the building during the year were quite numerous, and several rooms having been kalsomined and put in good order. A new roof was nearly completed. The education of the children was being carried on under the careful training of Miss Oliphant, and the home's school had been highly praised by the inspector of jails and charities. In closing her report, the secretary desired to express gratitude to those who had advanced the interests of a home in the right way.

Mrs. Gregoire's report as treasurer showed a balance on the right side. Fuel for the year had not been bought, however, and this surplus would probably be spent for that purpose.

The principal items of the year's receipts were made up as follows: Balance from last year, \$31.54; income from endowment fund, \$34.10; Overyment grant, \$250.00; city council grant, \$250.00; city collections, \$582.08; payment of board, \$649.70; legacy of late Mrs. McKel, \$50.00; interest on Mr. Abbott's bequest, \$20.77; donation from Adam Beck, \$100.00. The balance was made up of smaller donations. The total receipts for the year were \$2,205.12. The disbursements for the year were \$2,211.89, a balance of \$284.11 being left.

The estimated assets of the institution totaled \$29,175.15.

The growing value of the endowment fund was shown as follows: 1897, \$35,200.54; 1898, \$36,072.54; 1899, \$36,924.55; 1900, \$37,747.11; 1901, \$38,599.15; 1902, \$39,451.12. The increase from 1897 was \$2,251.61.

The City Council gave an illustration last night of what it can do in the way of speedy disposal of business in an emergency. The emergency session in the presence at the Council of "When Johnny Comes Marching Home," and the result was that the Council adjourned after sitting for about half an hour. There was, however, very little business which might have taken longer, even if Johnny hadn't come marching home.

The city was served with a writ of summons in the Sundry-Waterworks Commissioners suit for damages caused to the Blackfriars mill property by water backing up upon it since 1897. It was sent by the Council to the city solicitor to take what action may be necessary. The action in which judgment was rendered for the plaintiff in his suit with the Water Commissioners, was for damages previous to 1897.

A new proposition was presented by the London and Southwestern Traction Company for the one already before the council, and was sent to the finance committee. It asks for a by-law permitting it to forward its cars into the city, to be received by the present company and conveyed to the center of the city and back to the limit, and the City Council will require the London Street Railway Company to handle the cars as desired, and extend its lines to the city limits, to connect with the tracks of the traction company. If the present company refused, it is asked that the traction company be authorized to build to Elmwood avenue, there to connect with the line of the London company.

The mayor brought to the Council's attention the fact that in a number of cases citizens are being fined for the river, encroaching upon the channel. This was referred to No. 2 committee.

Ald. Dreaney gave notice of motion to enforce the carrying out of the street railway bylaw as it effects Rectory street, and that unless they do so

they shall forfeit their rights and privileges as provided for in bylaw 316. Ald. Dreaney asked if the company had been served with a notice of the Council's action in deciding to retain that line, and was told that it had. He said that they agreed to put down their extensions according to population and had not done so. His opinion was that serving the city with an injunction was simply done to keep the work back.

The Sifton bylaw was given its third reading and passed as amended by No. 2 committee. Ald. Jolly objected to it going through. He said that it did not insure competition, as the new company would not be authorized by it to erect poles, and he did not believe that they could get permission to string wires on others' property.

No. 2 committee will consider and report upon an application presented by Mr. Robt. Ironside for reinstatement as first assistant city engineer, and a refund of the part of his salary kept back since Sept. 1.

Under inquiries, Ald. McMechan asked the mayor to look into an action of the Council in appointing a fireman not appointed by No. 3 committee. It was the committee's prerogative, he said, to appoint the firemen, upon the recommendation of the chief. They had done this and the council had overridden them, raised the question simply so as to have the matter done properly, and his worship assured him that he would consult with the solicitor about it.

Ald. Cooper defended the action of the Council and Ald. McMechan reminded him that the police magistrate had once said that it was not for any reason, nor for the Council to override any bylaw. Ald. Cooper assented.

Mr. Walter Crossland asked, on behalf of the Cigar-makers' Union, that it be permitted to use the city hall on New Year's eve, for a ball and supper. The request was granted under the usual conditions.
