Who is to finalize the policy pertaining to the coal mining industry in Nova Scotia? Is it going to be the public or the government?

Mr. Muir (Cape Breton North and Victoria): That is a very good point, Mr. Speaker. Since it is a fact that it is now away over a year since the hon. member for Inverness-Richmond said there was going to be \$25 million made available to the coal mining industry, with \$10 million allotted to a new mine, when are we going to get some action?

Mr. Pearson: In respect of a policy of such importance involving such expenditures of money, and a policy which we hope will be in effect for many many years, surely the hon. member will agree that it is wise to take the necessary time to make sure that it is a right policy.

Mr. Diefenbaker: Why announce the policy if it is not a right policy?

Mr. MacInnis (Cape Breton South): Mr. Speaker, is the Prime Minister aware that the public, which has a real interest in the Nova Scotia coal industry, is very much aware of what the situation is? Is the Prime Minister not aware that the Minister of National Health and Welfare, within the last two weeks in the constituency of Inverness-Richmond, restated the promise to give \$25 million to the coal industry, including \$10 million to open the new mine at Lingan?

Mr. Pearson: I am sure my hon. friend will be very happy about the policy when it is announced.
