**Right Hon. P. E. Trudeau (Prime Minister):** Mr. Speaker, I am not aware of that particular case but I shall look into it.

### ADMINISTRATION OF JUSTICE

#### JUDGMENT IN CASE OF HUNTING INFRACTION BY ESKIMO

**Mr. G. W. Baldwin (Peace River):** Mr. Speaker, my question is for the Minister of Justice whom I welcome back from his daring and successful pursuit of the status quo over the last few days. Some time ago I asked the minister about the case of an Eskimo who had been convicted of an infraction of an ordinance of the Northwest Territories on an ice floe seven miles from the shore line. Is the government going to move to have that conviction quashed or does it accept the position that it has sovereignty in that particular area?

**Hon. John N. Turner (Minister of Justice):** Mr. Speaker, I gather that the hon. member is referring to the case of Tootalik. In the question the hon. member assumes that there was a finding of fact that the offence took place more than three miles from the shore line. Crown counsel for the Northwest Territories advises me, however, that the evidence is not clear on this point. In any event no decision is going to be taken on the position the Crown will take until we have made a review of the evidence.

**Mr. Baldwin:** A supplementary question, Mr. Speaker. In view of the fact that I understand the reasons for judgment indicate that the offence did take place that far out, will the minister not consider moving to quash the conviction in view of the government's position on the question of jurisdiction?

### GRAIN

#### WHEAT—OVER-QUOTA DELIVERIES TO PURCHASE SEED

**Mr. A. B. Douglas (Assiniboia):** Mr. Speaker, I have a question for the minister in charge of the Wheat Board. Has a decision been reached yet by the Wheat Board on whether or not prairie farmers will be allowed over-quota delivery privileges for the purchase of registered and certified seed?

**Hon. Otto E. Lang (Minister without Portfolio):** Mr. Speaker, I have been informed by the Wheat Board that the discussions have been successful and it is now intended to reinstitute over-quota delivery privileges to the extent of 400 bushels per permitholder with some additional regulation with regard to the use of this privilege which would assure the limitation of abuse.
