### PENITENTIARIES

KINGSTON—ESTABLISHMENT OF COMMISSION OF INQUIRY INTO RIOT

Mr. Jacques-L. Trudel (Montréal-Bourassa): Mr. Speaker, I have a question for the Solicitor General.

Could he say whether he intends to appoint a board of inquiry into the recent disorders at Kingston penitentiary or if such a board has already been set up?

Hon. Jean-Pierre Goyer (Solicitor General): Mr. Speaker, I am in a position to announce that the Commissioner of Penitentiaries has created a board of inquiry on the events which took place at Kingston penitentiary on April 14 to 18. Mr. J. William Swackhamer, Q.C., a lawyer from Toronto, has been appointed chairman of this board. Other members are Mr. W. T. McGrath, executive director of the Canadian Criminology and Corrections Association, and Mr. H. E. Popp, director of security, Canadian Penitentiary Service. Mr. Ian G. Scott, a Toronto barrister, will act as secretary and adviser.

I asked that the Board report to me at the earliest possible moment.

Mr. Trudel: Mr. Speaker, I have a supplementary question.

Will this Board consider the matter which was raised a short while ago with respect to the possibility of granting some sort of compensation to the guards who were kept as hostages?

Mr. Goyer: Mr. Speaker, the Board will have to stick to its terms of reference and I doubt that these will allow the Board to consider this matter.

#### NATIONAL PARKS

RECREATIONAL INTEREST OF UNITED STATES CITIZENS IN NORTHWESTERN QUEBEC AND NORTHERN ONTARIO

Mr. Gérard Laprise (Abitibi): Mr. Speaker, I should like to put a question to the Minister of Indian Affairs and Northern Development responsible for parks and recreational places.

For some time, now, American citizens have taken a tremendous interest in the abandoned lands of northwestern Quebec and northern Ontario, and especially in recreational areas. I would like to ask the minister if he has been in touch with provincial authorities and some citizens who have expressed concern over this invasion by American interests.
