In 1969 and 1970, has the government made grants to Northern Electric Company and, if so (a) in what amounts (b) on what date (c) in what part of the country?

FINANCIAL ASSISTANCE FOR DEVELOPMENT OF MEDICAL SCHOOL AT MEMORIAL UNIVERSITY IN NEWFOUNDLAND

Question No. 1,334-Mr. Carter:

1. Has financial assistance been promised the Province of Newfoundland by the Government of Canada from the Health Resources Fund in connection with the development of a medical school at Memorial University and, if so, what is the total amount of such assistance promised toward capital costs?

2. Has the Government of Canada made any commitment to assist financially toward the operating costs of the medical school at Memorial University and, if so, from what source?

Hon. John C. Munro (Minister of National Health and Welfare): 1. As of June 22, 1971 under the Health Resources Fund program, projects totalling \$1,991,025 for financial assistance to Newfoundland's Memorial University (Health Science Centre) have been approved. Of this amount \$170,170 has been paid to date to the province.

2. (a) Under the Federal-Provincial Fiscal Arrangements Act, 1967, the Government of Canada, through the Department of the Secretary of State provides financial support to assist the provinces towards the operating costs of post secondary education in medical schools. (b) Federal assistance towards the operating costs of teaching hospitals is also available to the provinces under the Hospital Insurance and Diagnostic Services Act.

PLACES OF RESIDENCE OF JUDGES OF THE SUPREME COURT OF ONTARIO

Question No. 1,361-Mr. McCutcheon:

Have any Judges of the Supreme Court of Ontario been granted leave to reside elsewhere in Ontario than at the City of Toronto or within five miles thereof and, if so (a) on what authority (b) what judges were granted such leave and, in each case (i) for what locality was residence leave granted (ii) what time was specified (iii) what, if any, conditions were imposed?

Hon. John N. Turner (Minister of Justice): Yes. (a) By Order in Council. Section 8 of the Judges Act provides that the Judges of the Supreme Court of Ontario shall reside at the City of Toronto or within five miles thereof but leave to reside elsewhere in the province for any specified time may be granted from time to time by the Governor in Council. (b) Upon their appointment to the Supreme Court of Ontario the following judges were granted leave to reside elsewhere than in the City of Toronto in order to enable their children to complete their school year and give them time to dispose of their homes and to find suitable accommodation in the City of Toronto: Hon.
