Member that I will not discuss details of these negotiations in public until they are concluded. # BANK BAIL-OUT—INFORMATION AVAILABLE TO PRIME MINISTER

Edward Broadbent (Oshawa): Considering that the Prime Minister, by his answer, has agreed that ministerial responsibility questions will be answered by the Government, I would like to ask him, considering that the Minister of State for Finance came into the House one Monday in March, gave an estimate of cost that was \$100 million less than the Inspector of Banks conveyed to Ottawa on the Sunday night, will he as Prime Minister answer for his responsibility and tell the House did he or did he not have this information on the weekend. Please answer.

**Right Hon. Brian Mulroney (Prime Minister):** The Hon. Member does well—he always does well until he adopts the Clarence Darrow pose. In point of fact the response of the Minister of State for Finance has been full and complete.

### An Hon. Member: Yes or no?

Mr. Mulroney: The Hon. Member yells yes or no. One of the reasons that we responded with a commission of inquiry was pursuant to strong suggestions made by the NDP who indicated in the House of Commons that the only manner in which this matter could properly be handled would be by a commission of inquiry. We sought out someone we thought was the most distinguished person in Canada in terms of independence to conduct this commission of inquiry, and we want to let him get on with the job, and do it.

### U.S.S.R.-EMIGRATION OF JEWS
