# OPPOSITION TO TAX ON FOOD

**Mr. Jean-Robert Gauthier (Ottawa—Vanier):** Mr. Speaker, I have the honour to present a petition, pursuant to Standing Order 106, which follows the numerous petitions I have tabled with the House for the last four or five weeks. The petitioners avail themselves of their ancient and undoubted right to present a grievance.

Whereas since September 1984 the federal Government has imposed on Canadian taxpayers 25 new taxes or tax increases, in particular, on medical, dental supplies, snack foods, candies and soft drinks, and whereas the federal Government in its tax reform proposal is studying the possibility of imposing on Canadians a general tax on goods and services, including food, and whereas food constitutes a vital element in day-to-day life, and whereas the imposition of this tax would have the effect of seriously penalizing certain categories of taxpayers such as the aged, families, the unemployed, low-income taxpayers, youth, and so on, the undersigned, your petitioners, humbly pray and call upon Parliament to reject all measures that would have the effect of imposing a sales tax on food products.

# **MOTIONS TO ADJOURN UNDER S. O. 29**

# CANADIAN SECURITY

Mr. Speaker: Applications under Standing Order 29.

Mr. Svend J. Robinson (Burnaby): Mr. Speaker, I seek leave, pursuant to the provisions of Standing Order 29, to move a motion for the adjournment of the House today on a matter of immediate and urgent concern, namely, the recent revelations regarding the Canadian Security Intelligence Service.

The series of information which has come out in recent days of CSIS infiltration of democratic organizations in Canada, including the labour movement, the peace movement, as well as legal political parties, give rise to grave concerns that must be dealt with on an urgent and emergency basis by the House.

In addition, clearly CSIS has dangerously mishandled its responsibilities in the area of counter-terrorism, including the Air-India disaster and the failure to take steps to provide for the protection of a visiting Punjabi cabinet minister.

In light of the series of events which have taken place and in light of the importance of an urgent debate on this situation, and, Mr. Speaker, in recognition of your earlier rulings under similar applications pursuant to Standing Order 29, I would hope there could be an emergency debate this evening on this serious and important question touching the civil liberties of all Canadians.
