NO HOLIDAY FOR CLERKS IN RUSSELL SAGE'S OFFICE

While His Body Awaits Burial, Work in His Office Goes On— "What Mr. Sage Would Have Wished," is Cashier's Explanation—The Sage Will Keep Secret from His Wife.

(N. Y. American, July 24).

"Under no consideration will I give any thought to my husband's will or other financial matters until after the funeral." The above statement was given out by Mrs. Russell Sage yesterday through two of her closest friends and advisers. The attention of Mrs. Sage has been directed to the fact that all the world awaits with impatient knowledge of the disposition of one of the world's vast fortunes. But, while Mrs. Sage has a keener sympathy with the wishes of most people and is fully cognizant of the importance of the trust of her husband's life work, she positively declined to consider the matter at present.

It was stated as coming direct from Mrs. Sage that she knows nothing of the provisions of her husband's will, and that she will not even set a date at this time for the breaking of the seal.

Mrs. Sage's friends were astonished when they learned that she knew nothing of the contents of her husband's will. It had been generally believed that she would handle most or all of his money, and the simple statement that she was ignorant of any of the provisions of her husband's will created surprise.

An impression is rapidly gaining credence, however, that the bulk of the vast fortune has been left to charitable and educational institutions. Spence in his charities through he was during his long years of life, it is generally understood that the benign influence of Mrs. Sage is responsible for a change of base, and his will may develop a charitable impulse the like of which has never been known in the world's history. Those in a position to know the contents of the document which will disclose the disposition of close to one hundred millions in money would not make a gambler's chance, which would give a definite idea of the provisions. But the air of secrecy pointed to a great surprise which the will would become known, and the fact that the world's charities were to benefit largely by the accumulations of a frugal life.

Not until after the burial in a Troy graveyard tomorrow will the will be filed for probate and the contents be made public. CZAR AND PEOPLE FACE TO FACE

By dissolving the Douma the Czar has taken a gambler's chance, with his throne and life as the stakes. Should his action precipitate a successful revolution the fate of the Czar is sealed. Should it, however, merely a premature outbreak, with the army remaining loyal to the crown, its savage suppression may give the Czar a fresh grip on the reins. That there will be no outbreak at all is a bold bet to make. The Douma was elected positively by the people, as is shown by placing St. Petersburg under martial law. For 24 hours before the dissolution of the Douma, the streets of the capital resounded to the marching of troops. The Czar delivered his defiance to the representatives of the people, back again by an immense army, hastily summoned from the surrounding country.

Again and again it has been declared that the issue rests with the army, and this may be repeated until the real feeling of the presents is understood. With only the active reformers and revolutionists to reckon with the army should be able to do the work expected of it. BIT NURSE ON THE ARM

Injured Victim of Framingham Disaster Became Insane and Tried to Eat His Nurse.

SOUTH FRAMINGHAM, July 25.—Among the many deeds of tireless sacrifice and noble endeavor that followed the catastrophic mine were more heroic than those of Miss Frances White, a nurse of the Framingham Hospital, and Dr. Mary A. Sweeney of Sherborn.

Dr. Sweeney is one of the efficient women physicians attached to the Women's Reformatory Prison in Sherborn, just across the Framingham line. Scarcely half an hour after the disaster building had collapsed she was at the scene, and she labored without any rest until 10 at night.

Nurse and doctor by turns, she bound up the wounds of the injured and soothed their suffering, rendering aid that proved as indispensable as that of any doctor present.

Miss White was on Alexander street at the home of Frank Howard, but when the mine crashed her arm was broken and she fainted from heat or exhaustion. Miss White was the first to render aid, and she worked indefatigably.

One Italian laborer being led away by Miss White, apparently unharmed save for bruises, suddenly went insane and bit deeply into her forearm. The plucky nurse fainted into Surgeon-Major McCourt's arms, while the Italian, realizing what he had done, covered her wound arm with kisses.

It was some time before Miss White recovered and it required the aid of several of those clustered about her to keep her from hurrying back to what she felt to be her duty.

"I must get back," she cried. "Let me go back to my work."

This afternoon, with her arm swollen and black, she started upon a trip to the hospital and helping Drs. Benner and Glass perform operations.

Miss White comes from Maynard, but has been in South Framingham for two years.
