TAXATION OF LIFE INSURANCE COMPANIES

Motion No. 109—**Mr. Saltsman:**

That an Order of the House do issue for a copy of all correspondence, memoranda, etc., between the Government of Canada and Canadian life insurance companies regarding the Budget proposals on taxation of life insurance companies.

Mr. H. E. Gray (Parliamentary Secretary to Minister of Finance): This motion is acceptable to the government with the customary proviso that any such correspondence containing information which if disclosed would prejudice the competitive position of an individual life insurance company would be excluded.

Mr. Speaker: Subject to the reservations or conditions expressed by the Parliamentary Secretary is it the pleasure of the house that notice of motion No. 109 be deemed to have been adopted?

PRELIMINARY REPORT OF O.E.C.D.

Motion No. 158—**Mr. Broadbent:**

That an Order of the House do issue for a copy of the Preliminary Report of the OECD submitted to the government after its assessment of Canada's Science Policy in 1968.

Hon. C. M. Drury (President of Treasury Board): Mr. Speaker, the report, the tabling of which is being sought, was received in draft form and is to be revised and published in the fall of this year. The Organization of European Co-operation and Development has asked that this document not be released pending publication of the final report. In view of this the hon. member might wish to withdraw the notice of motion.

Mr. J. Edward Broadbent (Oshawa-Whitby): Mr. Speaker, I am in a congenial mood today, and so I agree.

Mr. Speaker: Motion dropped.

Order discharged and motion withdrawn.

Mr. Speaker: Shall the remaining notices of motion stand?

Mr. David Orlikow (Winnipeg North): Mr. Speaker, more than two months ago the house agreed to a motion calling for the tabling of the research documents prepared for the Woods committee. I have not yet received them and I wonder when we will get some action on this?

Hon. Donald S. Macdonald (President of the Privy Council): Mr. Speaker, I recall the discussions which took place at the time and I will make an inquiry right away.

Mr. Frank Howard (Skeena): Mr. Speaker, two months isn't too bad. It is about six or seven months ago that some notices of motions in my name were adopted asking for the production of correspondence between the government and various provinces relating to the education of native Indian children, and an order made then has not yet totally been fulfilled.

Mr. Macdonald (Rosedale): I shall make inquiries about that as well, Mr. Speaker.
