



Crown Attorney J. B. MCKIIIOP Gives Opinion in Matter. "I think that the fees for members of coroners' juries should be in-creased," said Crown Attorney J. B. McKillop when interviewed today re-garding a report from Toronto that A. J. Lester who often acts for the crown at inquests there had recommended such action as a reform. Mr. Lester also recommended that the fine for fallure to attend by a jury-man should be increased from \$4 to \$50. Mr. McKillop stated that such action was not necessary here, because if an officer approached a citizen to serve on a jury and the citizen gave a good ex-cuse for its not being able to attend, he was fol forced to be amember. This caused a lack of truancy on the part of the jurors.

mit- 30-YEAR LEGAL SUIT REACHES HIGH COURT

OF UNITED STATES

Washington, Feb. 3 .--- A 30-year fight rowing out of the Government contract growing out of the Gevernment contract for dredging the Detroit River has just reached the supreme court with the ap-peal of the Government from an adverse decision from the court of claims. Le F, and J. A. Smith, contractors, in this judgment were awarded nearly \$120,000 for work done "outside of contract."
