Williams managed to drag himself to a drug store nearby, and was immediately sent to St. Michael's Hospital. The doctors consider his condition most critical.

#### SMALLPOX ON BOARD.

Passengers Detained on the Steamer Corinthian.

Halifax March 24 - Great excitement prevailed at the terminal pier yestrday After the Royal Mail steamer Corinthian, from Liverpool, had docked, it was discovered that a cattleman aboard was suffering from smallpox. The steamer had been boarded down the harbor by Dr. Mackay, the port physician, who, it is stated, was not informed by the ship's doctor that any sickness was aboard, and passed the ship. After the Corinthian was tied up at the pier the case was discovered, and all landing operations were at once suspended pending instructions from Otiawa. The mails were not allowed to be landed, and all the passengers are still aboard. The immigration agent declines to allow them to land. The steamer brought five hundred passengers, including thirty saloon. The result will probably be that the ship and mails will have to be fumigated. #### RAILWAY CLERKS.

An Emergency Meeting of the Ex ecutive Summoned.

Montreal, March 24.—The situaion as regards the local railway clerks has become serious enough, for Mr. C. E. Meyers of Toedo, President of the National Railway Clerks' Association, who arrived in Montreal on Saturday night, to send in Montreal on Saturday night, to send but telegrams calling a meeting of the aational Executive within twenty-four hours. The importance of this move may be appreciated from the fact that the members of the Executive are scattered over the eastern and middle States, and are never called to a special meeting except in case of emertency. Mr. Meyers will report upon the conditions as he has found them here, and will advise what action, if any, should be taken. Speaking of the situation to the correspondent of The Globe to-night, he said that he was not in a position to say what his advice would be or what would be the result.

Announcement That It Will Take Place in 1904.

London, March 23.-Mrs. Florence Maybrick, the American woman who vas convicted at Liverpool in 1889 o the charge of poisoning her husband, James Maybrick, at Aigburth, by arsenic, and whose sentence of was commuted to penal servitude for life, will be released in 1904. The an-nouncement comes from the Home Office, which now authorizes her Washington lawyers to use the fact of her release next year as a reason for serelease next year as a reason for securing the postponement of the trial of the lawsuits bearing on the prisoner's interest in land in Kentucky, Virginia and West Virginia until she is able to personally testify. Those who are in a position to know say that Home Secretary Akers-Douglas has shown great courtesy in connection with the suits now pending in America, that the decision to release Mrs. Maybrick was due entirely to efforts on this side of the Atlantic, and that Ambassador Herbert never has been called upon to act in this has been called upon to act in this

### FORGED MORGAN'S NAME.

Count Maurice de Bosdari's Creditors Lose \$160,000.

London, March 24.—The first meeting of the creditors in the bankruptcy of Count Maurice de Bosdari, who was connected with the recent forgeries of J. Pierpont Morgan's signature on bills purporting to have been given in payment for purchases of bric-a-brac, and who disappeared when the forgeries were discovered, was held here. The petitioning creditor is Alfred Hickman, former President of the British Iron Trade Association, holder of one of the forged bills, for \$57,500, drawn by De Bosdari, apparently with Mr. Morgan's acceptance, which was presented for payment at a London bank early in February, and which Mr. Morgan repudiated. #### COUP BY FILIPINOS.

Town Captured and Several Police

Manila, March 24.—The Town of Surigao, in the northeastern part of the Island of Mindanao, was captured yesterday by Filipino insurgents, who killed Constabulary Inspector Clarke and several others. A detachment of 30 men belonging to the 10th Infantry, under the command of Lieutenants Patterson and Brown, is hurrying from Illiagan, on the northwest coast of Illiagan, on the northwest coast of Mindanao, to Surigao, in the transport Reilly with orders to recapture the

Reilly with orders to recapture the town.

Brigadier-Gen. Sumner, commanding the department of Minando, has been ordered to send two additional companies of troops to Surigao. It is reported that the Filipinos are holding the town, but details of the fight have not been received. The fate of the white officials and other foreigners is not known. If they have been captured vigorous measures will be taken to rescue them. This is the first time American troops have been first time American troops have been used since peace with the Moros was

The woman set fire to the house, and the bodies of three of the children were badly burned. Persons attracted by the smoke gave the alarm, and the flames were extinguished in time to show the results of the tragedy. It is thought the woman was insane.

March 23.-A terrific explosion of gas yesterday in the mine of the Athens Coal Company at Athens, twenty miles north of Spring-field, resulted in the death of six men meld, resulted in the death of six men and the serious injury of another. All were miners, principally foreigners. An entry had been stopped up on account of gas. It was drilled open yesterday and a blast nearby set off the gas.
