CHISHOLM, COLIN. (*Cape Breton.*)

Grandparents emigrated to N. S. from Strathglass, Scot. B. at Long Point, Inverness Co. N.S., 1850. Ed. at Halifax. M., 1885, Evaline, dau. of Alex. McInnis, Sydney. Is a practising Barrister, and has been Clerk of the Municipality of Cape Breton. First returned to Ho. of Assem. at last g. e. A Conservative, and opposed to the "Secession party" in N. S.—*Sydney, N.S.*

CHURCH, Hon. CHARLES EDWARD. (*Lunenburg.*)

Of English and German descent. Paternal ancestors came to Am. 1622, with the Pilgrim Fathers. Great-grandfather, Charles Church, a Loyalist, removed from U. S. to N. S. during Am. revolution; grandfather, Charles Lot Church, represented Lunenburg in N. S. Assem. B. at Tancook Island, Lunenburg, N.S., 1835. Ed. at Chester and Truro. M., at Halifax, 24 June, 1884, Miss Henrietta Pugsley. A merchant. Has held official positions of trust in the Grand Lodge of British Templars, and in the Grand Division of the Sons of Temperance, N. S. Sat in the Commons for present seat from g. e. 1872 until g. e. 1878, when he was defeated. First returned to Ho. of Assem., N. S., at last g. e. Sworn a mem. of Ex. Council, N. S., and apptd. Provl. Secretary, 3 Aug., 1882. On resignation of Hon. Mr. Pipes, and the reconstruction of the Administration by Hon. W. S. Fielding, became Commr. of Works and Mines, 26 July, 1884. Re-elected by acclamation on taking office, 22 Aug., 1882, and re-elected at last g. e. A Liberal. Believes that the financial terms to N. S. under B. N. A. Act are far too small to maintain the services under the control of the Local Govt. To ensure efficient maintenance of local works, the Dominion Govt. should readjust the subsidies payable to the various Provinces.—*Halifax; Chester, N.S.*
