Chief Williams has received word, rom Detroit that the authorities have offered a reward of \$500 for the arrest of John H. Carmichael, believed now to be the murderer of Gideon Browning, at Rattle Run, Michigan.

The description given is as follows: years old; 6 feet, 6 inches tall; weighs 180 pounds; broad shoulered; athletic build.

He walks with a slight limp and a trifle stooping. Because of his having had both legs broken, his right foot turns out a little, while his left foot "toes out" at an angle of about 45 degrees.

His hair is brownish, tinged with grey, while the whiskers he wore when he disappeared are lighter in color and dappled with grey.

There is a scar on the left side of his nose, and another on his upper lip. His eyes are light bluish-grey. He was once shot through the knuckle of one of his little fingers and the same has since been badly swollen. His ears stand out prominently from his head. He carries a gold, open-faced watch, but no other jewelry. When talking, he uses the ministerial intonation. Chief Williams Speaks.
