investigations to find out to what extent, if any, the Unemployment Insurance Act might apply to a reasonable number of those who are engaged at sea in the fishing industry, many of whom are self-employed.

I hope to have a further report to make on this topic before many weeks. Even though it should be found that a plan could be formulated to provide coverage for fishermen generally, it will take a good deal of time to work out anything like a practical detailed plan. If a practical plan can be devised, while its effect upon the fund must be considered by the unemployment insurance advisory committee, it may not require an amendment to the act but may be put into effect by regulation under the authority of the governor in council.

Mr. T. S. Barnett (Comox-Alberni): Mr. Speaker, I should like to address a question to the Minister of Labour in connection with a statement he made earlier on the Unemployment Insurance Act. Can the minister assure the house that the changes which are being made by regulation in connection with the inclusion of fishermen will be made during the current session of the house so that hon. members will have an opportunity of discussing the proposals that are brought forward?

**Mr. Gregg:** Mr. Speaker, I can make no promise regarding the time factor, but I can assure my hon. friend that since I have the unemployment insurance estimates still to be completed before the estimates committee and before the committee of supply of this house there will be plenty of opportunity to discuss his point.
