Mr. Laing: It will be in the mail tonight.

Mr. H. W. Herridge (Kootenay West): I wish to direct a question to the Prime Minister. May I ask whether the heartwarming reference to the role of the monarchy made by the Minister of Justice in Victoria a few days ago represents government policy?

Right Hon. L. B. Pearson (Prime Minister): We all, with a few exceptions, make heartwarming references to the monarchy, and I hope we shall continue to do so.

Mr. R. W. Prittie (Burnaby-Richmond): Would the Prime Minister follow the lead of the minister of consumer affairs and make a public expression of his views on the shabby treatment Vancouver is getting from the National Hockey League?
