Mr. Frank Howard (Skeena): Mr. Speaker, I wish to direct a question to the Minister of Indian Affairs and Northern Development. Is there presently being undertaken or has there just been completed a study by officials in his department, or by someone appointed for that purpose, in conjunction with the province of Quebec or directly through his department, into the question of jurisdiction relating to native Indian people and Eskimos in the province of Quebec?

Hon. Arthur Laing (Minister of Indian Affairs and Northern Development): Mr. Speaker, I am rather happy that the hon. member has raised this question, because I read a press report which spoke of a secret document having been exchanged between or delivered to both the federal government and the government of Quebec. There were other sinister suggestions that an arrangement was going to be made, and I want to assure my hon. friend that there is simply no justification whatever for the inferences included in the report.

At present all this consists of is a working paper which has been delivered to each government as a basis for financial considerations in the transfer to Quebec of those services which are necessary in that part of Quebec due to the very considerable mining and other developments that are proceeding in that part of the province. The work of my officials and that of the officials of the province of Quebec is entirely consistent with the last statement I made in the house on this matter on March 4, 1964, at page 505, where I said provision was made to refer these principles and conditions to a joint committee of federal and provincial officials who are charged with the responsibility of preparing a draft agreement as well as the terms of reference for the commission which will be asked to receive Mr. Speaker, the first note was replied to the views and comments of the Eskimos.
