#### THE CANADIAN ECONOMY

RENEGOTIATION OF AUTO PACT SAFEGUARDS AS PRECONDITION TO REMOVAL OF UNITED STATES IMPORT SURTAX

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, I should like to ask the Prime Minister a question arising out of the reported statement of Mr. Petty, the United States Assistant Secretary of the Treasury, that the removal of the transitional safeguards in the auto pact is definitely an item to be negotiated before the United States will remove the import surtax. Is it the position of the government that the two questions are linked, and that satisfactory renegotiation of the safeguards in the auto pact is a precondition to the removal of the surtax?

Hon. E. J. Benson (Minister of Finance): Mr. Speaker, that is not the case. The auto pact has been discussed by the two governments, through the Minister of Industry, Trade and Commerce and the United States treasury and trade and commerce departments. There have been continuing negotiations. My understanding of the press reports is not that Mr. Petty was saying that this was a condition precedent or anything else but that it was simply a factor he was raising as being unsolved at the present time.
