Mr. Jones: Mr. Speaker, on a point of order; on February 3 of this year, almost five months ago now, I put a question on the order paper, No. 1,455, which occupies one word more than three lines. I wanted to know how much money had been spent by the government on cancer research, heart research and medical research and I have not yet had an answer. It is both important and essential that this question be answered, and I should like to ask the government House leader or his parliamentary secretary why it has not been answered.

I ask, Mr. Speaker, that the other notices of motions be allowed to stand.
