TABLING OF AGREEMENT AMONG NATIVE GROUPS, GOVERNMENT OF CANADA AND GOVERNMENT OF QUEBEC

MOTOR VEHICLE SAFETY ACT

MEASURE TO PROVIDE FOR INSTALLATION IN MOTOR VEHICLES OF PASSIVE RESTRAINT CRASH PROTECTION DEVICES

Mr. David MacDonald (Egmont) moved for leave to introduce Bill C-444, to amend the Motor Vehicle Safety Act (passive restraint crash protection devices).

He said: Mr. Speaker, the purpose of this bill is to substantially reduce the number of injuries and deaths in highway accidents. It requires the installation of a passive restraint system, specifically instantly-inflatable air bags, in all cars manufactured in or imported into Canada after 1980.

CANADIAN AND BRITISH INSURANCE COMPANIES ACT

MEASURE TO PERMIT INSURANCE COMPANIES TO INVEST IN BONDS OF GOVERNMENT OF ISRAEL

Mr. Bob Kaplan (York Centre) moved for leave to introduce Bill C-445, to amend the Canadian and British Insurance Companies Act.

He said: Mr. Speaker, the Canadian and British Insurance Companies Act limits the insurance industry to investing in government securities only of the countries listed in the act. Presently on the list are such countries as Southern Ireland, Southern Rhodesia, the United Kingdom, Trinidad and Tobago, and so on. The purpose of this amendment is to add to that list the state of Israel so that the industry could also invest in state of Israel bonds
