# REASON FOR REDUCTION OF WAGE INCREASE FOR ATLANTIC SUGAR EMPLOYEES

**Mr. Mike Landers (Saint John-Lancaster):** Mr. Speaker, my question is for the Minister of Finance. Has the minister had an opportunity to inquire into the roll-back of wages at the Atlantic Sugar Refineries of Saint John and, if so, what has he discovered?

Hon. Donald S. Macdonald (Minister of Finance): Yes, Mr. Speaker. The board arrived at the conclusion that it should allow a basic increase of 8.29 per cent on the basis that the previous contract had been reopened during its lifetime. Indeed, there had been an opportunity to catch up with the increase in the consumer price index. The board has indicated that it is meeting with the company today, and is likely to meet with the union tomorrow. It is prepared to consider the question again in light of the facts that either or both of those parties can bring to its attention.

#### UNIFORM ENFORCEMENT OF SAFETY RULES AT AIRPORTS— GOVERNMENT ACTION
