REQUEST FOR MEASURES TO REDUCE INTEREST RATES— MOTION UNDER S.O. 43

Mr. Eudore Allard (Rimouski): Mr. Speaker, pursuant to Standing Order 43, I ask the unanimous consent of the House to present a motion on an urgent and important matter.

Considering that the Pepin Board has not seen fit to control interest rates, particularly debit and credit rates, considering that the gap now exceeds 4 per cent, which is the largest in recent years, and considering also that current interest rates are really very high, I move, seconded by the hon. member for Bellechasse (Mr. Lambert):

That this House instruct the Minister of Finance to take every necessary step to bring back interest rates at the level they were when the economic development was quite satisfactory, that is a normal rate of 6 per cent, and to avoid that in future Canadians be forced to contract loans at current interest rates which is one of the first causes of inflation.
