TRANSPORTATION FOR MINISTER OF STATE FOR FITNESS AND AMATEUR SPORT

Question No. 147—**Mr. McKinnon:**

1. With reference to the answer to Question Nos. 2,538 and 2,881 of the Second Session of the 30th Parliament, was the cost for the trip of the Minister

of State for Fitness and Amateur Sport while in Europe, calculated on a 24 hour per day basis for a total of \$378,504 and, if not, what calculations were used?

2. What was the total cost to the public of Falcon flight 3013, which left Canada, Uplands Airport on April 20, 1977, until the time when the Minister of State for Fitness and Amateur Sport finished using the plane and returned to Canada?

Hon. Barney Danson (Minister of National Defence): 1 and 2. The Falcon aircraft in support of the Minister of State for Fitness and Amateur Sport in accordance with the schedule listed in question No. 2,538 of the second session of the thirtieth parliament flew a total of 27 hours, thirty minutes. For further details see question No. 2,881 of the second session of the thirtieth parliament.

Hon. André Ouellet (Minister of State for Urban Affairs): I am advised as follows by Central Mortgage and Housing Corporation: 1. At November 30, 1977 the Canadian Home Insulation Program had 64 employees on staff at its Montreal office, 48 of whom were regular and 16 contract.

Question No. 761—**Mr. Howie:**

Since January 1, 1977, what amount was paid, and to whom, by Atomic Energy of Canada Limited for agent's fees, sales commissions or expenses in respect of sales of Candu reactors?

Hon. Alastair Gillespie (Minister of Energy, Mines and Resources): Atomic Energy of Canada Limited reports as follows: Nil. However, retainer fees of \$4,000 were paid on June 15, 1977 and November 23, 1977 to Gebhart Y Asociados, Consultores, Apartado postal 5-901, Mexico, D.F. for representational services rendered in marketing Candu power stations.
