Mr. Rae: Mr. Speaker, I want to assure the minister that we on this side in our party share her concern that welfare recipients should have the benefit directly, and that they should not suffer as a result of provinces failing to pass on benefits. My question relates to provinces like Alberta which have not as yet said whether they will agree to this commitment. A letter from the province of Alberta, dated November 17, 1978, to the executive director of the National Anti-Poverty Organization indicated that even at that time they had not yet made up their mind whether they were going to change their legislation to have the desired effect. Can the minister tell the House whether she is prepared to give a regular report to this House indicating which provinces are giving effect to the legislation and which provinces are not?

Miss Bégin: Mr. Speaker, it is an excellent, but an uncomfortable, suggestion which I accept. I will make a regular report for the House.

Hon. Jean Chrétien (Minister of Finance): Mr. Speaker, I have not seen that letter. I am very surprised at what the hon. member said and I would like to analyse the problem. Of course, when you have a social insurance number you cannot invent another number. That is my judgment. However, I would like to look into it.

Mr. Clark: Mr. Speaker, I will be delighted to make available a copy of the letter from the then minister of national revenue, his then colleague, dated November 22, 1977, in which he stated that was the case. I would like an undertaking from the Minister of Finance that he will inquire of the Bank of Canada whether they are, in fact, pursuing his highly inventive policy, and report back to the House on that matter as quickly as possible.

Mr. Chrétien: I do not think that is a question, Mr. Speaker: everyone knows I am a very diligent minister.
