Mr. Speaker: In my opinion the nays have it.

Mr. Knowles (Winnipeg North Centre): On division.

Mr. Speaker: I declare the motion defeated on division.

Motion No. 4 (Mr. Rae) negatived.

Mr. Speaker: The question is on motion No. 5 in the name of the hon. member for Humber-St. George's-St. Barbe (Mr. Faour):

Motion No. 5

That Bill C-14, an act to amend the Unemployment Insurance Act, 1971, be amended in clause 3 by striking out line 6 at page 2 and substituting the following therefor:

"sections 17(5) and (6), has been".

"tions (2) and (4) do not apply to an insured person where the national rate of unemployment which applies to his occupation, as defined by Statistics Canada, is greater than four per cent."

Motion No. 8

That Bill C-14, an act to amend the Unemployment Insurance Act, 1971, be amended in clause 4 by striking out line 2 at page 3 and substituting the following therefor:

"tions (2) and (4) do not apply to an insured".

Motion No. 9

That Bill C-14, an act to amend the Unemployment Insurance Act, 1971, be amended in clause 4 by striking out lines 2 to 5 at page 3 and substituting the following therefor:

"tions (2) and (4) do not apply to an insured person where the regional rate of unemployment that applies to him is greater than four per cent."

Those in favour of the motion will please say yea.

Some hon. Members: Yea.

Mr. Speaker: Those opposed will please say nay.

Some hon. Members: Nay.

Mr. Speaker: In my opinion the nays have it.

And more than five members having risen:

Mr. Speaker: The motion will be decided by a recorded division.

I earlier ruled that on procedural grounds motion No. 11—the minister is rising on a point of order.

Mr. Cullen: Mr. Speaker, when I introduced motion No. 11 I knew it was not in order on procedural grounds and that I would need the unanimous consent of the House in order that it be adopted. I gave that undertaking at the committee stage. I believe there is a general disposition to give unanimous consent so that motion No. 11 can be carried.

Mr. Baker (Grenville-Carleton): That is correct, Mr. Speaker. Consent is given as far as this party is concerned.

Mr. Knowles (Winnipeg North Centre): Agreed.

Mr. Beaudoin: Agreed.

Mr. Speaker: The minister would require the consent of the House to present this motion at this time. Is there unanimous consent?

Some hon. Members: Agreed.

Hon. Bud Cullen (Minister of Employment and Immigration) moved:

Motion No. 11

That Bill C-14, an act to amend the Unemployment Insurance Act, 1971, be amended by adding immediately after line 5 at page 4 the following new clause:

"4.1 Paragraph 18(2)(a) of the said act is repealed and the following substituted therefor:

'(a) incapable of work by reason of any prescribed illness, injury, quarantine or pregnancy'"
