Orange (Parliamentary Secretary to Minister of Energy, Mines and Resources): Mr. Speaker, with reference to motion No. 138 for the production of papers dated since January 1, 1969, exchanged between the government of Canada and the government of the United States in relation to a study of the possibilities of diversion of water from the Shuswap River, I wish to advise that there has been no exchange of papers of the nature referred to by the hon. member, either through the Department of External Affairs or through the Department of Energy, Mines and Resources. Under the circumstances I would ask that the hon. member withdraw his motion.
