TAYLOR, GEORGE L., *M.D.* (*Kings.*)

S. of late Geo. Taylor, a native of Monaghan, Irel., who was for some years a merchant in St. John. B. in St. John in 1842, and ed. there and at Sackville Acad. Graduated M.D. at Bellevue Hospital Medical Coll., N.Y., 1863. Has been a County Councillor and was Warden of Kings in 1879. First returned to Ho. of Assem. at g.e. 1886, and re-elected at last g.e. A Conservative.—*Hampton, N.B.*

THERIAULT, *Lieut.-Col.* LEVITE, *J.P.* (*Madawaska.*)

Of Acadian origin. B. at St. Basil, N.B., 1837. Ed. at St. Ann's Coll., P.Q. M., 13 Jan., Eugene, dau. of Edward Le Bel, of Kamouraska, Q. Is a farmer, Lieut.-Col. Reserve Militia, and Warden of his County. Has been a mem. of the Provl. Board of Agriculture, and Secy. of the Victoria Central Agri. Soc. Honorary Commr. 1891 from N.B. to the Exhibition of Jamaica. Was a mem. of the Executive Council from July, 1871, to Feb., 1872. Sat for Victoria from 1867 to g.e. 1871, when returned for the new County of Madawaska, which he continued to represent until at g.e. 1882, he resigned in favor of his opponent. Re-elected at last g.e. Resigned and was an unsuccessful candidate at the Commons election, Feb., 1887. Re-elected to Ho. of Assem., April, 1887. and by acclamation at g.e. 1890.—A Conservative.—*St. Basil, N.B.*

TURNER, GAIUS SAMUEL, *J.P.* (*Albert.*)

S. of Isaac Turner and Elizabeth Colpits. B. in Albert Co., 12 Aug., 1838. Ed. there. M., 16 Aug., 1876, Lucy E. Stiles. Engaged in shipbuilding and merchandising. A J.P. and Dir. of the Albert Railway. First returned to Leg. at g.e. 1878, re-elected at g.e. 1882, 1886 and 1890. Was a mem. of the Ex. Council from March, 1883, to Oct., 1889. A Liberal Conservative.—*Harvey Albert Co., N.B.*
