ADVANCES to farmers for lifting crops and marketing cattle. The Bank will also under-take, as financial agents, to negotiate high-class commercial and municipal loans, and will transact any desirable business appertaining to the operations of finance.

NOTE.--It is not intended to "work up" an aggressive competition, or to give or receive excessive interest, but rather promote business in sympathy with the best form of banking and legitimate trade, no matter where the business comes from.




