Hon. G. J. McIlraith (Minister of Public Works): 1. Yes.

2. The Ottawa Board of Trade proposed the establishment of a zoo in the Ottawa area. Envisioned was a zoological garden located on a 200 acre site, partially on city of Ottawa property and partially in the green belt, in the vicinity of Green creek, north of the Queensway.

3. The centennial administrator, to whom for the consideration of the proposal for the establishment of a zoo.

4. The idea is not under active examination at this time.
