**Mr. Baldwin:** Why have you taken so long?

**Mr. Douglas (Nanaimo-Cowichan-The Islands):** A supplementary question, Mr. Speaker. In view of the Prime Minister's statement yesterday about an adjournment of the house in the early summer, can he give the house an assurance that before parliament recesses legislation will be introduced to place some restraint on unjustifiable price increases, in order that the Canadian people may know that the government is seriously trying to stop this spiralling cost of living?

**Mr. Trudeau:** I doubt very much that any type of legislation has ever been suggested, including that from the N.D.P., but may I remind the house that we did introduce several cuts in very important areas across the country in the past months, and in each case the opposition parties have told us to re-establish these vast expenditures which we had to cut down.

**Hon. George Hees (Prince Edward-Hastings):** I have a supplementary question for the Prime Minister. He stated in the house on September 13 that the government's attack on poverty could be centred on an attempt to control inflation. Can he tell the house with any assurance that he expects in the months ahead the government's attack on poverty in this regard to be a great deal more successful than it has been since last September?

**Mr. Trudeau:** I cannot venture to prophesy the effects of our future actions. I will just remind the house that had we heeded the opposition pleas and not proceeded with the cuts, inflation would have been a great deal worse.

**Some hon. Members:** Oh, oh.

**Mr. Hees:** Does the Prime Minister not agree that what he just said is a further example of his many attempts to mislead the Canadian people on most of the important matters?

**Mr. Speaker:** Order, please. I think the further supplementary question is argumentative.

**Mr. Hees:** It is just a statement of fact.
