Right Hon. P. E. Trudeau (Prime Minister): I would prefer that this matter, if it is to be dealt with at all, be touched upon by the minister responsible. I can say at this stage that there is no intention in my mind of recommending the establishment of such a committee. However, as the hon. member knows, I have an open mind on all these things.

Mr. Alexander: I am glad to learn that the Prime Minister has an open mind on this question. He will understand that in the absence of a standing committee on housing and urban affairs the new portfolio he is developing will have no credibility whatsoever in terms of participatory democracy.

RETIRED EMPLOYEES' PENSIONS—ACTION TO IMPLEMENT COMMITTEE RECOMMENDATION FOR INCREASE

#### POLLUTION

OTTAWA AREA RIVERS—ESTABLISHMENT OF WATER QUALITY MANAGEMENT AREA

Greene (Minister of Energy, Mines and Resources): Mr. Speaker, discussions are going on with the province of Ontario and the province of Quebec under the aegis of the consultative committees appointed pursuant to the philosophy of the Canada Water Act, both provincially and federally. I am very hopeful that we can achieve an agreement in the not too distant future which will embrace the two provinces and the federal government.

PURPOSE OF TROOP MOVEMENT FROM QUEBEC TO MONTREAL

MacLean (Malpeque): Mr. Speaker, I should like to inquire whether the Prime Minister or the Minister of National Defence is in a position to enlighten the House as to the purpose of moving 30 truck loads of troops to Montreal in the middle of last night, I believe it was. Was this just an exercise, or since it is alleged that most of the vehicles were of a medical services nature has the government of Quebec asked the federal government for assistance in connection with the provision of medical services in that province?

Hon. Donald S. Macdonald (Minister of National Defence): Mr. Speaker, this was a night training exercise between Canadian Forces Base Valcartier and Canadian Forces Base Camp Bouchard, and was not at all in relation to the situation referred to by the hon. member.
