Fuca, I would ask the minister if the government has had active discussions with the United States on the possibility of having all Alaskan oil delivered to points on the U.S. west coast south of Vancouver Island, where there are far fewer navigational hazards than in the Strait of Juan de Fuca?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Yes, Mr. Speaker. That is exactly the point we have made to the United States on many occasions.

Mr. Macdonald (Rosedale): On a question of privilege-

Mr. Speaker: Is the minister rising on a point of order?

Mr. Macdonald (Rosedale): On a question of privilege with regard to the remarks of the Leader of the Opposition, Mr. Speaker. I think it is only fair from my standpoint to indicate that the State Department had agreed to release the information on July 6, and it was only on July 9, when we found they had not released the clarification and, at their request, that we submitted the letter on July 10. It was our understanding that they would release that information on July 6, and it was only when we found out that they did not do it that we sent them further clarification.
