## Order Paper Questions

Hon. Allan J. MacEachen (Secretary of State for External Affairs): 1. A list of companies was prepared on the basis of competence and normal professional standards from all those registered with CIDA. The criteria for selection were professional qualifications, relevant and related past experience, availability of expertise, ability to undertake the work, overseas experience and language requirements. The list of five companies was presented to the SSEA with CIDA's recommendations for his approval. The contractor was selected on the basis of best price and ability to meet the tender requirements.

2. (a) (i) Within the financial limits of the project, no proposal call is required. The firm of Beauchemin, Beaton, Lapointe was selected. (ii) Canadian Comstock, Dominion Bridge. (b) Canadian Comstock was the successful bidder.

5. Records of visits or travel by CIDA and/or Department of External Affairs members are not maintained by project as travel is related to overall programs involving several specific areas of interest, and records are normally kept on this basis. Travel costs by CIDA and/or Department of External Affairs members are not charged to project funds.

6. Only Canadian citizens or landed immigrants may be employed on CIDA projects under normal circumstances. There is, however, no record of the number employed, as this information is not required for purposes of payment. Payments are made relative to the specific performance within the scope of work and the payment budget or, according to approved rates by discipline and total time worked, depending on the contract. The actual number of individuals employed is the prerogative of the consultant or contractor.

### PRAIRIE FARM ASSISTANCE ACT

## Question No. 3,293—Mr. Murta:

Are there any exceptional circumstances to explain the reason that, in the last year of existence of the Prairie Farm Assistance Act (crop year 1973-1974), benefits paid totaled \$524,880.50 and administration expenses totaled \$486,741.97 and, if so, what are they?

Hon. E. F. Whelan (Minister of Agriculture): There were exceptional circumstances involved relative to the benefits paid and the administrative expenses incurred by the Prairie Farm Assistance Administration for the crop year 1973-74 as indicated in the 1973-74 Report of Activities under the Prairie Farm Assistance Act. The costs of the Prairie Farm Assistance Administration of \$486,741.97 in 1973 include the cost of salaries of all permanent employees of the administration, amounting to \$372,049.32. These permanent employees of the Prairie Farm Assistance Administration were responsible for the operation of the Grassland Incentive Program involving payments to producers amounting to \$16.8 million, as well as the operation of the Prairie Farm Assistance Program.

A request for a further contribution has been received. This request is currently under consideration by the Fitness and Amateur Sport Branch of the Department of National Health and Welfare.
