**LABOUR CONDITIONS****UNEMPLOYMENT STATISTICS**

Labour force statistics are out today and they document the fact that 309,000 fewer Canadians are working today than were working one month ago. Rather than the Minister simply calling upon the Opposition to salute him because of a statistical drop in the rate of unemployment, I wonder whether he is prepared to do something real for the 309,000 Canadians who are not working and who were working a month ago.

**Hon. John Roberts (Minister of Employment and Immigration):** Madam Speaker, I think the Hon. Member knows that the appropriate assessment is to look at what is happening to employment figures in a seasonally adjusted way. For some reason the Hon. Member wants to put the worst possible interpretation that he can on the figures, and to welcome with gloom and doom every sign he can find, even when he distorts them, to justify taking that position. The fact is that for every month since last November there has been an improvement in the employment situation, and that is shown in the figures. I would have thought that the hon. gentleman would have been happy about that rather than seeming to take some enjoyment in the fact that he can find some reason for sadness.

**UNEMPLOYMENT IN GASPÉ REGION OF QUEBEC**
