*[English]***HEALTH****FOOD IRRADIATION REGULATIONS—REVIEW PROCESS**

Mrs. Mary Collins (Capilano): Mr. Speaker, my question is for the Minister of National Health and Welfare. As the Minister knows, new regulations regarding food irradiation were gazetted this week which will provide for applications to irradiate food to be reviewed on a case by case basis.

While a few of the recommendations in the report of the Standing Committee on Consumer and Corporate Affairs were included in the regulations, many were not.

Given the real public concern and scepticism about the whole issue of food irradiation, would the Minister once again consider a major recommendation of that report that a consultative panel, including scientists and consumer representatives as well as government officials, be established to review and advise the Minister on any submissions to irradiate food, so that the public will be more confident and assured of the openness and independence of the review process?

Hon. Jake Epp (Minister of National Health and Welfare): Mr. Speaker, the Hon. Member raised this issue in the report. We looked at it seriously when we responded to the report. The Department of National Health and Welfare, specifically the Health Protection Branch division, has within it professional chemists, nutritionists, microbiologists, toxicologists, and other professionals, including the radiation group, to deal with these issues.

We regularly get advice from outside groups. I think it is important that the regulatory process within the Department of National Health and Welfare remain intact for the Minister and for the scientific advice from the Department.

Although I know it is a repeat of the points which the Hon. Member and her committee made, at the moment I believe that we have in place a consultative process without formalizing it beyond what we now have.
