Today, however, we celebrate with our friends in Namibia and with the many Canadian organizations and individuals who have contributed to this historic event, including the non-governmental organizations, the RCMP and the Canadian military, many of whom live in my riding, who have been to Namibia and contributed to this historic event.

Namibia independence marks the final chapter of a decolonization process of over 40 years in Africa. The last colony in Africa—that has a wonderful ring to it. Today we celebrate Namibia for all of Africa.

In closing, it is with great excitement and enthusiasm that the New Democratic Party welcomes an independent Namibia into the international community.
