SCRUTINY OF REGULATIONS

SECOND REPORT OF STANDING JOINT COMMITTEE

Mr. Derek Lee (Scarborough—Rouge River): Mr. Speaker, I have the honour to table the second report of the Standing Joint Committee on the Scrutiny of Regulations.

In accordance with Standing Order 123, it is my duty to inform the House that this report contains a resolution to revoke the agricultural exhibition loans order, Consolidated Regulations of Canada, 1978, chapter 318.

Pursuant to Standing Order 123(1), a copy of the order is attached as appendix A to this second report.

This report constitutes a portion of the disallowance procedure set out in Standing Order 123.

Mr. Danis: Mr. Speaker, I would like to ask for unanimous consent to waive notice and introduce legislation which would deal with return to work of the grain handlers in Thunder bay.

Mr. Murphy: Mr. Speaker, we are willing to waive notice to have the bill printed and circulated at this time. It is also our intention to allow the debate to commence later today if the government should so choose, but until we see the legislation and how the minister reacts to certain amendments and suggestions we cannot make any guarantees as to when the debate would finish.

Mr. Speaker: I wonder if I could assist the House. The hon. minister has moved for consent to introduce the bill. I take it that consent is given. However we need a royal recommendation which is not yet with us.

Under the circumstances I would ask that we stand this down until the royal recommendation arrives and then proceed.

Is there agreement on that?

Some hon. members: Agreed.

Mr. Speaker: Agreed and so ordered.

TELEVISIONING OF PROCEEDINGS OF SPECIAL JOINT COMMITTEE

That, notwithstanding the report of the Standing Committee on Elections, Privileges, Procedures and Private Members' Business concurred in by the House on October 20, 1989, the following will be the order of priority for access to the parliamentary channel during the mandate of the special joint committee on the Government of Canada's proposals for a renewed Canada.
