MASONRY MAY ERECT A TEMPLE.

Circumstances Are Necessitating a Decision of Much Interest to the Craft in This City.

It is altogether probable that the Masons of Toronto will get together and decide on the erection of a modern Masonic Temple. At present a number of the lodges are quartered in the T.O.P. Temple on Bay Street. Notices have been given that on expiration of the lease a considerable increase in rent will be demanded. The feeling of those high in the craft is voiced in a circular letter issued by H. Leeson, secretary of the Masonic Hall Trust, which, in part, says:

"The board suggests that the matter be taken up and considered as soon as the various lodges, and their representatives, future action presents itself in three different ways: (1) The continuation of the present lease at the increased rental. (2) The leasing of other premises in new buildings to be put up in the near future in Toronto. (3) The purchase of a site and the erection of a Masonic Hall to be owned by the craft exclusively. The present lease is for four years to run from Dec. 31, 1903; but a conclusion ought to be arrived at as soon as possible by all of the lodges of the trust, so that action can be taken. If the lodges come to the conclusion that it is advisable to purchase a site on which may be erected a suitable building for the Masons, it is suggested that they should for each lodge to ascertain what amount it would be willing to put into the undertaking, the cost of which we think would be not less than \$75,000."

SICK FIREMEN ARE IMPROVING.

No More Fatalities Expected—Course in First Aid to Injured Proposed by Chief.

The condition of the seven firemen who were victims of the fumes which proved fatal to their comrades was improved last night, and unless complications unforeseen occur there will be no further fatalities. Chief Thompson visited each one last night and was much relieved to hear the good news.

The funeral of Fireman Potter will take place on Monday afternoon at St. James' Cemetery. He will be given full fire department honors. The statement that the authorities at St. Michael's Hospital did not give Cecil Stewart proper care existed solely in the poor fellow's delirium. Those who at the time have been taken there for treatment have always had the best and most attentive care bestowed upon them, and the whole department appreciate the fact. In order that the firemen may be better educated to the dangers that exist from chemicals and other substances, and to counteracting the injurious effects thereof, Chief Thompson intends to formulate a course for his men in first aid to the injured, taking in all manner of harm which may befall the fireman in the daily performance of his hazardous duty.

REPORT OF EXHIBITION BOARD.

Erection of Auditorium to Hold 20,000, for Cattle Judging, Asked as an Immediate Necessity.

The annual report of President Mought and board of the Industrial Exhibition was issued in printed form yesterday. Under the caption of "Suggestions," it says:

"Your board considered that it was important to have the dates of this year's Exhibition fixed as early as possible, and have therefore selected Aug. 29 to Sept. 10 as the dates. They have also decided to designate it, 'The Canadian National Exhibition of Toronto.' 'The many improvements and additions have been made to the buildings during the past year, there is still much required. The present administration building is entirely inadequate, and a new one should be erected at once. The entrance must be improved, so as to provide better accommodation. A fireproof addition to the art gallery is an absolute necessity, and a large covered auditorium, capable of seating 20,000 people, is required for the exhibition of cattle and horses. At the present time the public cannot at all times get a good view of the animals being exhibited, and during inclement weather the judging is seriously interfered with, and the spectators are obliged to wait for a long time. An addition to the transportation building is also required, as well as improvements to the implement building. A judging ring for swine, together with sleeping accommodation for the animals, is a duty which we must provide this year. We trust that your association will see fit to authorize the new board to proceed with these improvements at the earliest possible moment.'"

DEVONSHIRE AGAINST GOV.

London, Feb. 19.—In the House of Commons, the Duke of Devonshire (Liberal-Unionist), made a long speech on the fiscal question. He explained his position and his reasons for his resignation as Lord President of the Council, and said when he read Mr. Balfour's speech he found he had altogether misconceived Mr. Balfour's views. Consequently, the Duke could not continue to remain in the cabinet. Continuing, the Duke said the only result of a retaliatory duty on American iron would be to raise the home trade of temporary inconvenience. In conclusion, the Duke expressed the strongest disaffection with the attitude of the government.
