Canadian ports is, nevertheless, the basic policy of both the Canadian National Railway management and the Canadian government.

Coastal Service—1921, first two months of operation August to October \$60 per month; October to December \$67.50 per month. 1922, \$67.50 per month.

Australian and Oriental service—1921, January to July, \$75 per month; July to December, \$60 per month; 1922, \$60 per month; 1923, \$60 per month.

Vancouver—U. K. Service—1921, commenced operation November, 1923, \$60 per month.
