

Questions

2. At the present time, the immunization status is known for only 45 cases. Thirty one had received no Salk vaccine and of these 3 had received Sabin vaccine. Six had received one or two doses of Salk vaccine and of these one had received Sabin vaccine. Eight had received three or more doses of Salk vaccine and of these none had received Sabin vaccine.

3. (a) The time interval between feeding Sabin vaccine and occurrence of symptoms varied from 17 to 48 days. (b) Two cases had severe permanent paralysis and 2 cases had moderate paralysis which, at last examination, were showing much improvement.

*VOCATIONAL TRAINING, TORONTO

Question No. 181—Mr. Lewis:

1. What assistance under the Technical and Vocational Training Assistance Act has the government provided and undertaken to provide in the province of Ontario, and what part of it, if any, was or is designated for the municipality of Metropolitan Toronto?

2. How much of any such assistance was in respect of the capital expenditure incurred by the province of Ontario on training facilities, and what part of such assistance related or relates to such capital expenditure in the municipality of Metropolitan Toronto?

3. What representations, if any, have been made to the Minister of Labour or any departments or agencies of the government with respect to the inadequacy of present training premises and facilities in the municipality of Metropolitan Toronto, and what steps is the government considering in order to provide assistance in respect of capital expenditure for the building of additional facilities there?

Mr. Hales:

1. From April 1, 1961 to September 30, 1962, the total federal government contribution to all types of programs coming under the Technical and Vocational Training Assistance Act in the province of Ontario is \$51,300,000. The amount of this total contribution relating to the municipality of metropolitan Toronto is not immediately available.

2. The estimated federal share of all training facilities that have been built or purchased since April 1, 1961 or approved up to October 15, 1962 in the province of Ontario is \$187,000,000. Of this total, \$37,500,000 relates to the municipality of metropolitan Toronto.

3. As of October 15, 41 projects have been recommended by the province and approved by the federal government for new schools, additions and improvements to existing training facilities for the municipality of metropolitan Toronto. The federal government will consider further applications as they are received from the province in accordance with terms of the agreements.

VOCATIONAL TRAINING FOR UNEMPLOYED

Question No. 194—Mr. Berger:

1. How many of the unemployed persons enrolled full-time in occupational training courses between April 1, 1960, and March 31, 1961, pursuant to the special vocational projects agreement, completed said courses, and, of those who completed the courses, how many obtained jobs within three months following completion of their courses.

2. Was the new technical and vocational training agreement, referred to in the annual report of the Department of Labour for the fiscal year ended March 31, 1961, at page 78 thereof, completed with the provinces and, if so, what was the date of completion, and is the province of Quebec a party to the said agreement?

3. How many unemployed persons were enrolled in occupational training courses, pursuant to the special vocational projects agreement or the technical and vocational training agreement, between April 1, 1961, and March 31, 1962?

4. Did the federal government share in the cost of any other vocational training courses for unemployed persons during the period between April 1, 1961, and March 31, 1962?

5. Of those unemployed persons enrolled in the courses mentioned in parts 3 and 4, (a) how many completed said courses (b) how many failed to pass said courses (c) how many obtained employment within three months of completing their courses (d) how many were men (e) how many were women (f) how many were enrolled in the province of Quebec?

Answer by: Mr. Hales:

1. (a) Between April 1, 1960 and March 31, 1961, 2,848 unemployed persons completed courses.

(b) Number obtaining jobs within three months following completion, not available.

2. Yes, with all provinces including Quebec, effective April 1, 1961.

3. 26,887.

4. No.

5. (a) 9,646, (b) 6,569—(10,672 still under training, April 1, 1962), (c) Unavailable, (d) 20,306, (e) 6,581, (f) 8,308.

*IMPORT OF CEMENT CARGO, MONTREAL

Question No. 199—Mr. Robichaud:

Was a cargo of cement imported from a foreign country unloaded in the port of Montreal since October 1, 1962, and, if so (a) what was the quantity of cement involved (b) what was the country of origin (c) what is the name of the broker responsible for this transaction (d) what was the name of the Canadian firm taking delivery of this cargo?

Mr. Flemming (Victoria-Carleton): The answer to the first part of the question is yes.

Part (a)—1050 metric tons.

Part (b)—The shipment arrived from Cuba but there is reason to believe that the cement originated wholly or in part in the U.S.S.R.

Parts (c) and (d). It is not the government's practice to disclose information concerning the business of individual importers or their agents.
