At the same time, I advised the ministers concerned that I was asking for such an investigation to be undertaken, and they approved of my decision.

It is the result of this investigation, as far as the R.C.M.P. could make it, that is reflected in the answer given to question 2,423 on the

order paper.

As far as the second part of the question put a moment ago by the right hon. Leader of the Opposition is concerned, he will understand that under the rules of the house I must take it as notice, but I can assure him that I will immediately take steps to obtain the required information.

As regards the matter of bankruptcies and any investigation in bankruptcy frauds, it is clear that from the strict point of view of federal jurisdiction, any information that could be obtained is restricted to what the superintendent of bankruptcy has in his possession because of his official function. Bankruptcy frauds as such being criminal offences come under the attorney general of the province and the investigation made in the case of the companies in which people were or are involved, as I understand, was made and is being carried out probably in the name and at the instance of the attorney general of the province.
