Hon. C. M. Drury (Minister of Industry): At the time of the feasibility study composition by computer conducted by the Canadian government printing bureau, the staff in the area in question numbered 80. The staff estimates under the proposed process was 52, a reduction of 28 man years, or 54,600 hours.

This committee recommended that an ad hoc committee be appointed to study in depth the whole problem of poisonings by acetylsalicylic acid and products containing this drug and to make suitable recommendations in respect thereof. This ad hoc committee has now been appointed to study the matter.
