## EXTENSION OF EMERGENCY GOLD MINING ASSISTANCE ACT

#### Question No. 853-Mr. Orange:

- 1. Is any action being taken to extend the Emergency Gold Mining Assistance Act beyond its proposed expiry date in 1967 and, if not, when will a decision be made on whether or not to extend the Act?
- 2. If the act is to be extended, is it intended to remove the provisions excluding assistance to gold mines coming into operation in areas outside established gold mine communities as defined by the Act?

Hon. Jean-Luc Pepin (Minister of Mines and Technical Surveys): 1. The Emergency Gold Mining Assistance Act was extended in December 1963 for a period of four years to the end of 1967. The amendment to the act did not change the formula used in computing the amount of assistance payable to the gold mines. However, the amending legislation did introduce a restriction which affects a new gold mine coming into production after June 30, 1965. After that date a new gold mine is eligible for assistance only if it provides direct support to an existing gold mining community.

Although no direct action is presently being taken to extend the act, we are well aware of the needs of the gold mining industry and the situation is constantly under serious study.
