Inquiries of the Ministry

that medicare, so far as the federal government is concerned, is a cost-sharing arrangement with the provinces. The administration is entirely within their area of responsibility and jurisdiction. They have not asked that any role be played by the federal government in this.

Mrs. MacInnis: A supplementary question, Mr. Speaker. Since medicare—

An hon. Member: The minister has just answered your question.

Mrs. MacInnis: Yes, and I will ask another one. Since medicare is a federal-provincial cost-sharing scheme and since it is essential for medicare to work better and for the public to have confidence in it, does the minister intend to insist on a full investigation of these charges which indicate that very serious practices are going on?

Mr. Munro: Mr. Speaker, I answered the hon. member's question precisely as to whether we were investigating this particular area of alleged abuse, and the answer was no. The province has not asked us to investigate. If, on the other hand, she wishes to know whether we are behind the provinces and support them in attempting to cut down wastful expenditures and abuses of this kind, the answer is yes.

ADULT OCCUPATIONAL TRAINING ACT—INQUIRY WHETHER COURSES WILL BE TERMINATED BEFORE COMING INTO FORCE OF AMENDMENTS

People presently on courses will not be affected by this bill; it simply widens the scope of the program and permits people who were previously ineligible for courses to become eligible.

PICKERING TOWNSHIP SITE—PROVISION OF INFORMATION TO MEMBERS OF PARLIAMENT
