DEFENCE CONSTRUCTION (1951) LTD.—POSSIBLE TRANSFER TO DEPARTMENT OF PUBLIC WORKS

Question No. 1,356-Mr. Herbert:

Has consideration been given to transferring the responsibilities of Defence Construction (1951) Limited to the Department of Public Works and, if not, for what reason?

Hon. James Richardson (Minister of National Defence): In 1962 the Royal Commission of Government Organization chaired by Mr. J. G. Glassco, and in 1967-68 the Bureau of Management Studies and in 1971-72 the Management Review Group of the Department of National Defence all gave consideration to the most appropriate location for Defence Construction (1951) Limited. Each time this matter was considered it was agreed that in order to meet the objectives of the Department of National Defence a quick response capability was required within the department.
